**RE: Request for an investigation of the King County Transportation Concurrency program, team and management for legality of actions and potential misconduct.**

This is an investigation request under RCW 9A.72.020 and King County Ordinance 3.42.030. It also pertains to elements of RCW 36.70A.070.

We, the Travel Forecasting and Data Management group (TFDM), working for the King County Department of Transportation, Roads Services Division, CIP & Planning Section, request that the King County Prosecuting Attorney's Office conduct a thorough investigation of the King County Transportation Concurrency program, team and management. We have also filed a complaint with the King County Ombudsman's office (February 6, 2003) that is currently under investigation.

The TFDM group believes that the King County Transportation Concurrency program may have deliberately provided false information to the King County Council, and that the King County Council adopted Transportation Concurrency Ordinances based on that information. We also believe that portions of the ordinance developed by the Transportation Concurrency program were developed in part to act as protection from challenges to arbitrary and inaccurate assumptions used to issue a Concurrency Certificate for the Redmond Ridge East (RRE) development, as well as other developments.

In addition, the Transportation Concurrency program may have used those Ordinances adopted based on false information to fight against citizens in Hearing and Appeal processes.

In addition, the TFDM suspects that the Concurrency program has not completely complied with RCW 42.17. The TFDM suspects that crucial emails and documents have not been disclosed to citizens when asked for information and emails related to the Transportation Concurrency program.

The TFDM believes that the Transportation Concurrency team may be in violation of County, State, and/or Federal laws, and requests a full and complete investigation of this program.
